SILVER LININGS

Silver linings are perhaps the greatest gift of 2020. They are the small but powerful reminders that there is hope even in pandemic darkness – like time for family walks, Zoom gatherings to celebrate birthdays, and actually making those recipes filed away for a rainy day. 2020 was a year of unanticipated silver linings for Heritage Fund, and we are grateful to share them with you. Our grantmaking focused on COVID-19 relief and its many community impacts, including providing for immediate day-to-day needs, helping students continue studying and creating infrastructure assistance for nonprofits suddenly working in very new ways.

HFBC staff discovered new ways to work with donors and grantees and stay connected with each other. We were awarded a \$3.5 million Community Leadership Grant from the Lilly Endowment, one of 11 awarded in a statewide competitive process, to sustain the cultural heritage work of Landmark Columbus Foundation.

In August, the HFBC Board adopted a two-year guided study and reflection initiative on racial equity. HFBC Board members committed to lead by example, learn to have those uncomfortable conversations and break down barriers that keep us from being an inclusive, equitable and welcoming community.

We trust 2021 will give us more opportunities to gather. In a recent donor survey, you told us you wanted to learn more about issues in our community, see more data and discuss some of the ways to create positive impact. We have been working on both the data and the stories to give you a better overview of the philanthropic landscape in Bartholomew County.

2020 has provided HFBC staff, board and committees a return to the core of our mission, which is to support individuals, families and organizations in defining and implementing their philanthropy. Your Philanthropy. Your Way. provides a range of services and vehicles that let you find your own unique way to give back to your community.

I hope you enjoy learning more about each of these 2020 silver linings in this report.



## **Capacity-Building Grants**

Organizational Excellence Grants are intended to support training, development and capacitybuilding opportunities for nonprofit staff and boards. Organizational Excellence Grants are varied based on the specific needs of local nonprofits and can be used to support activities, including strategic planning, board development, communications and fundraising planning, network and IT planning, succession planning, leadership development, organizational assessment and productivity improvements.

# **Foundation For Youth**

After reaching full capacity for its after-school club, summer club and Youth Camp program, Foundation For Youth was awarded \$102,000 over two years in 2019-20 to fund an associate director position to assist with the strategic operational and facility growth of the organization. Support from Heritage Fund through this grant proved to be a valuable asset in responding to the challenges of 2020.

"The pandemic required significant work to build a safe response for our wide range of participants and our employees. The associate director's position took a very lead role in the ongoing development of those tools. This position further allowed the executive director role to focus more heavily on the development and implementation of a Business Response Plan. Separately, the pandemic has stretched our employee pool thin. Significant work revolves around ensuring the most efficient service we can provide," said Executive Director Chuck Kime.





# **Advocates for Children**

After receiving specific recommendations from a strategic fundraising audit, Advocates for Children was awarded \$60,000 over two years in 2019-20 to support a director of resource development position. Since 2019, this position has implemented a new donor management software, pivoted fundraising from in-person to online events and created new direct mail fundraising campaigns to help Advocates for Children meet its mission.

# Sans Souci

During a crucial time of organizational development, Sans Souci received \$70,000 over two years in 2019-20 to support Sans Souci managers on the path to financial stability. Stable salaries for management positions allowed Sans Souci to continue its work with developing employees and increased the productivity of the organization. Sans Souci has been able to grow significantly in several areas since fulfilling these crucial positions in 2019, with the most noticeable growth in the store sales, social media, Employee Development program and the quantity and quality of services offered to community members. After filling these positions, Sans Souci guickly noticed an increase in monthly store sales and was thrilled to end 2019 with store sales reaching \$90,000 over its targeted goal.

# NAACP of Bartholomew County

The NAACP of Bartholomew County received \$1,500 in 2020 to strengthen membership communications. The grant allowed the NAACP to update its website, mail campaigns and membership forms ahead of its annual membership drive and officer elections.

# **Racial Equality and Equity**

In August 2020 the Heritage Fund Board adopted a resolution:

"HFBC Board and Governance and Planning Committee will spend the next 18-24 months studying and reflecting on the issues of racial equality and equity and how the community foundation can use its ability to convene and engage the broader community and direct our resources to promote efforts to support this work."

The Board will:

- Prioritize Progress Over Comfort
- Engage in Courageous & Respectful Discussions
- Learn before Acting & Share the Journey with Others
- Identify Areas for Action

They began with attending the "Interrupting Racism" training led by Child Advocates of Indianapolis. The Board believes that in order for Bartholomew County to become the welcoming community it is striving to be, the entire community must be proactive in addressing racism and equity. It is important to first learn, then reflect, then act. It is the Board's hope that Bartholomew County can be used as an example and encourage other communities to take a similar journey.

Heritage Fund has a long history of investing in the growth and well-being of our community. Through this initiative, we are seeking to help catalyze courageous conversations within our Board and eventually with the larger community to recognize and address racial inequities. As one Board member put it, "In order to discover new oceans, we need to lose sight of our familiar shores."

EDUCATE, CONNECT AND INSPIRE WOMEN TO PRACTICE STRATEGIC PHILANTHROPY



### Women's Giving Circle

The mission of the Women's Giving Circle is to educate, connect and inspire women to practice strategic philanthropy by using collective strengths and financial resources to create positive change in Bartholomew County. More than 100 local women joined or renewed their membership in 2020 and supported these highlighted initiatives:

- High-Impact Grant Program Circle members selected COVID-19 relief as the focus area and awarded a \$10,000 grant to Su Casa Columbus to assist local women and children negatively impacted by the pandemic.
- Women's Leadership Pipeline Intern Kate Stewart completed an analysis of gender representation on local nonprofit boards, city/county committees, commissions, etc., and the group is currently working with other community partners to connect more women to local leadership opportunities.
- Women in Crisis Micro-Loan Program 

   In partnership with Lincoln-Central Neighborhood Family Center, WGC provided grant funds to assist women in need. Grants supported items such as unexpected emergency expenses, monthly bill assistance, and job preparedness etc.
- Community Book Read In an effort to expand knowledge of racial equity, WGC members and other women from the community participated in book read/discussion of Robin DiAngelo's "White Fragility."
- Women's Suffrage Event WGC hosted an event at the Bartholomew County Historical Society to commemorate 100 years of suffrage. The event showcased the traveling exhibit "Securing the Vote: Women's Suffrage in Indiana," on Ioan from the Indiana Historical Society/Indiana Humanities.

# COVID-19 RELIEF

# **COVID-19 Organizational Resiliency Grants Program**

Nonprofit organizations worked tirelessly to provide immediate relief to those who needed it most during the COVID-19 pandemic. Their response did not come without high costs to our local nonprofit network. Organizations were burdened with decreases in revenue while they saw an increase in need for their services. Health and safety guidelines prompted many organizations to move their services online for virtual delivery and incur unexpected technology costs. Remaining in-person services now require extensive personal protective equipment and policies to prevent the spread of the virus. While costs increased, fundraising decreased for many organizations that rely on public support for their daily operations.

Heritage Fund developed the COVID-19 Organizational Resiliency Grants Program to assist local nonprofits with organizational needs identified in response to the pandemic. The program distributed more than \$100,000 to Bartholomew County nonprofits to help them adapt to the "new normal."

Grants were submitted throughout 2020 and helped to fund:

- Zoom subscriptions for virtual service delivery
- Laptops and other IT hardware for virtual work
- Updates to IT infrastructure, phone and Internet speeds
- Support for online programming
- Sewing machine for mask creation
- New HIPPA-compliant client management software

The Organizational Resiliency Grants Program helped local nonprofits to adapt throughout the pandemic and was replenished with another \$100,000 to continue the program in 2021.

# **Emergency COVID-19 Relief Scholarship Fund**

By pooling unawarded scholarship dollars from several individual scholarship funds, Heritage Fund donors enabled us to establish a one-time Emergency COVID-19 Relief Scholarship Fund to aid Bartholomew County students who were facing financial hardship because of the pandemic. Thirty students received \$56,000 in scholarship assistance.

# The Mask Project

With the help of volunteer sewists, Columbus Area Arts Council produced free masks that were available from safe pick-up locations throughout Bartholomew County. Through The Mask Project, artists, designers, crafters and sewists served not only as leaders and ambassadors of arts and culture but also of public health.

Heritage Fund was happy to support this CAAC project along with Columbus Regional Health and Healthy Communities Proyecto Salud Action Team with a \$20,000 Positive Change grant to make these free masks available to the community!

Visual artist Pierre Obando discussed his design for The Mask Project: "My design combines a couple of exploratory drawings that were made separately from each other. The relationships that resulted from their modular repetition in a pattern was intriguing and is a springboard for future paintings and drawings. I wear a mask because wearing a mask protects others and signals that the pandemic hasn't gone away."

# United Way Emergency Assistance Grant

**MATCHING FUNDS** 

\$25,000

At the beginning of the COVID-19 pandemic in March 2020, United Way of Bartholomew County stepped up to lead the charge on emergency fundraising through the United Way COVID-19 Relief Fund. Heritage Fund contributed \$25,000 in matching funds to the campaign. By June, United Way had raised more than \$600,000 for the relief effort. Since then, United Way has distributed funds to organizations that provide direct relief in the form of food, clothing, shelter, and assistance for rent, utilities other immediate needs to children, adults and families who have been affected by COVID-19.
